LOCAL UNIT BYLAWS 2 Revised January 2009 - Amended July 2009, June 2010, July 2011, April 2013 3 **ARTICLE I: NAME** 4 5 The name of this association is the Arcado ES PTA Parents and Teachers Association, Lilburn, Georgia. It is a local PTA/PTSA 6 7 organized under the authority of the Georgia Congress of Parents and Teachers, a branch of the National Congress of Parents and 8 Teachers (the National PTA). 9 10 **#ARTICLE II: PURPOSES** 11 12 **Section 1.** The purposes of the PTA are: 13 a. To promote the welfare of children and youth in home, school, community, and place of worship; 14 b. To raise the standards of home life; 15 c. To secure adequate laws for the care and protection of children and youth; d. To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the 16 17 education of children and youth; and e. To develop between educators and the general public such united efforts as will secure for all children and youth the 18 19 highest advantages in physical, mental, social, and spiritual education Section 2. The purposes of the PTA are promoted through an advocacy and educational program directed toward parents, teachers, 20 and the general public; developed through conferences, committees, projects, and programs; and are governed and qualified by the 21 22 basic policies set forth in Article III. 23 Section 3. The association is organized exclusively for the charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code (hereinafter 24 25 "Internal Revenue Code"). 26 **#ARTICLE III: BASIC POLICIES** 27 28 29 The following are basic policies of National PTA and the Georgia PTA: 30 a. The association shall be noncommercial, nonsectarian, and nonpartisan; b. The association shall work with the schools and community to provide quality education for all children and youth 31 and shall seek to participate in the decision-making process establishing school policy, recognizing that the legal 32 responsibility to make decisions has been delegated by the people to boards of education, state education authorities, 33 and local education authorities; 34 c. The association shall work to promote the health and welfare of children and youth and shall seek to promote 35 collaboration between parents, schools, and the community at large; 36 d. No part of the net earnings of the association shall inure to the benefit of, or be distributable to its members, 37 directors, trustees, officers, or other private persons except that the association shall be authorized and empowered to 38 pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the 39 purposes set forth in Article II hereof; 40 e. Notwithstanding any other provision of these articles, the association shall not carry on any other activities not 41 permitted to be carried on (i) by an association exempt from federal income tax under Section 501(c)(3) of the 42 Internal Revenue Code or (ii) by an association, contributions to which are deductible under Section 170(c)(2) of the 43 Internal Revenue Code; 44 f. Upon the dissolution of the association, after paying or adequately providing for the debts and obligations of the 45 association, the remaining assets shall be distributed to one or more nonprofit funds, foundations, or associations 46 that have established their tax-exempt status under Section 501(c)(3) of the Internal Revenue Code and whose 47 purposes are in accordance with those of the National PTA; and 48 The association or members in their official capacities shall not, directly or indirectly, participate or intervene (in 49 g. 50 any way, including the publishing or distributing of statements) in any political campaign on behalf of, or in opposition to, any candidate for public office; or devote more than an insubstantial part of its activities to attempting 51 52 to influence legislation by propaganda or otherwise. 53 **#ARTICLE IV: RELATIONSHIP WITH NATIONAL PTA AND GEORGIA PTA** 54 55 Section 1. This local PTA/PTSA shall be organized and chartered under the authority of the Georgia PTA in the area in which this 56 local PTA/PTSA functions, in conformity with such rules and regulations, not in conflict with the National PTA Bylaws or the 57 Georgia PTA Bylaws. 58

Each local association in good standing; that has forwarded its state and national portion of membership dues as shown on the books of the state office, has submitted an annual audit report to the state office by the last business day of September and has 400 approved by laws on file shall be entitled to be represented at the annual state convention by its president and one (1) other officer, 401 402 or their alternates, and one (1) delegate for every fifty (50) paid members recorded in the state office. 403 Section 2. Funds for convention expenses shall be included in the budget of this PTA/PTSA. 404 405 **ARTICLE XVI: FISCAL YEAR AND IRS FORM(S)** 406 407 Section 1. The fiscal year of this PTA/PTSA shall begin on <u>August 1</u> and end on the following July 31. 408 Section 2. The fiscal year is: 409 a. A twelve month period used for filing the appropriate 990; and 410 b. Registered with the IRS when the first 990 is filed. Section 3. All PTAs/PTSAs are required to file a 990N, or 990EZ regardless of gross receipts. The appropriate 990 is due the 15<sup>th</sup> 411 day of the 5<sup>th</sup> month after the close of the fiscal year. (Failure to file a 990 for three (3) consecutive years will result in the loss of tax 412 413 exempt status.) 414 **#ARTICLE XVII: PARLIAMENTARY AUTHORITY** 415 416

which they are applicable and in which they are not in conflict with these bylaws, the National PTA Bylaws, the Georgia PTA
Bylaws, or the articles of incorporation.

- b. Notification of the proposed amendment(s) has been provided to the membership thirty (30) days prior to voting;

    - d. The amendment(s) shall become effective upon receipt of approval from the Georgia PTA.
- 429 #Section 2. The adoption of an amendment to any provision of the Georgia PTA Bylaws identified by a number symbol (#) shall 430 automatically amend the bylaws of the local PTAs/PTSAs to conform to the action taken by the state convention.
- 431 Section 3. Each local PTA/PTSA shall receive from the Georgia PTA an updated version of its local unit bylaws which shall
   432 include any recent amendments adopted by the Georgia PTA convention delegates.
- 433 **Section 4.** In the event that a revised set of bylaws is required by the Georgia PTA and there are no changes in the local PTA/PTSA 434 information stated in the current bylaws, the thirty (30) day waiting period is waived.
